Program Description: The Merit Company and Sherwood Company offer a \$1,000 renewable annual scholarship to LCCC and University Partnership students who meet the following criteria:

1. Is entering into or resides with an immediate family member who is entering into a new one year lease agreement on the same terms and conditions as other non-scholarship residents of any of the following apartment complexes: College Park Townhouses, Commodore Arms, Sherwood Forest Apartments; and
2. Is enrolling at LCCC or its University Partnership in not less than two (2) three-hour credit courses during at least two (2) semesters for the academic year and maintains a C average in those courses.

Program Restrictions: Only one (1) \$1,000 scholarship will be awarded per lease agreement. Scholarships will be paid directly to the student upon verification of successful completion of coursework.
